

## One Lucky Fan – Season Ticket Giveaway

### Official Rules

**NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT INCREASE CHANCES OF WINNING. THE ONE LUCKY FAN – SEASON TICKET GIVEAWAY (THE “CONTEST”) IS INTENDED FOR PARTICIPATION ONLY IN THE STATE OF ARIZONA (THE “TERRITORY”) AND SHALL BE CONSTRUED ACCORDING TO AND GOVERNED EXCLUSIVELY BY ARIZONA STATE LAW. DO NOT PARTICIPATE IN THIS CONTEST IF YOU ARE NOT A LEGAL RESIDENT WITHIN THE TERRITORY, PHYSICALLY LOCATED WITHIN THE TERRITORY AT THE TIME OF ENTRY, AT LEAST EIGHTEEN (18) YEARS OF AGE, OR DO NOT FALL WITHIN THE ELIGIBILITY REQUIREMENTS SET FORTH IN THESE OFFICIAL RULES. VOID WHERE PROHIBITED BY LAW.**

1. **CONTEST DESCRIPTION:** The Contest is sponsored by IceArizona AHL Co LLC d/b/a the Tucson Roadrunners (the “Roadrunners”). The Contest, entry form located at [tucsonroadrunners.com](http://tucsonroadrunners.com) shall be available from 12:01 a.m. MST on May 30, 2022, to 11:59 p.m. MST on June 12, 2022 (the “Contest Period”). One (1) potential prizewinner will be selected by the Roadrunners to receive a prize, as described below. Limit of one (1) entry per person or entity. Odds of winning depend on the actual number of eligible entries received. By participating in this Contest, each entrant unconditionally accepts and agrees to comply with and abide by these rules (the “Official Rules”) and the Roadrunners’ decisions regarding the Contest, which shall be final and binding.

2. **WHO MAY ENTER:** This Contest is open only to legal residents of the state of Arizona who are eighteen (18) years of age or older at the time of entry, and physically located within the state of Arizona at the time of entry. Employees, agents, officers, directors, members, managers, and owners of the Roadrunners, IceArizona Holdings LLC, IceArizona Hockey Co LLC, the Arizona Coyotes Foundation, the National Hockey League (the “NHL”) and its member clubs, and each of their respective parents, subsidiaries, affiliates, owners, members, directors, managers, officers, employees and their advertising agencies, promotional partners and prize providers associated with this Contest (each a “Promotion Entity” and collectively the “Promotion Entities”), and their immediate family members (spouses, domestic partners, parents, legal guardians, grandparents, grandchildren, siblings, children and “step” of each) and those individuals living in their same household are not eligible to enter or win. A potential prizewinner of the Contest may be required to show documentation to confirm eligibility.

3. **WHEN TO ENTER:** The Contest shall be conducted from May 30, 2022, at 12:01 a.m. Mountain Standard Time (“MST”) until June 12, 2022, at 11:59:59 P.M. MST. To be eligible for this Contest, the entry must be properly submitted as instructed and received by the Roadrunners during the Contest Period. The Roadrunners’ database clock shall be the official time keeping device for all entries received in connection with this Contest.

4. **HOW TO ENTER:** To be eligible for the Contest, an entrant must visit [tucsonroadrunners.com](http://tucsonroadrunners.com) during the Contest Period and follow the instructions on the Contest registration page to submit an entry. Each entrant must complete and submit all required information. The Roadrunners will receive the following information regarding each entrant: first name, last name, date of birth, email address, phone number, address, and entrant’s favorite Roadrunners’ memory/moment. Each entrant that submits an entry must be qualified to win the Prize (as defined below). No purchase is necessary to enter. Participation is limited to one (1) entry per person.

Proof of entering the required information at the <https://www.tucsonroadrunners.com/gameday/22-23-season-ticket-giveaway/> is not considered proof of delivery to or receipt by the Roadrunners of entry into the Contest. In the event of a dispute regarding the identity of who submitted an entry, the entry will be deemed submitted by the authorized account holder of the email address supplied at the time of entry. An “authorized account holder”

is defined as the natural person to whom the applicable email address has been assigned by the internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning email addresses for the domain associated with the address submitted. A potential prizewinner may be required to provide proof that he or she is the authorized account holder of the email address associated with the winning entry.

No mechanically reproduced, illegible, forged, software-generated, other automated, or incomplete entries will be accepted. The use of any device to automate the entry process is prohibited. Contest entries will be deemed null and void and will be rejected if not submitted through authorized, legitimate channels. If a dispute as to the identity of any entrant cannot be resolved to the Roadrunners' satisfaction, the entry will be deemed ineligible.

Each entrant agrees that the information collected in connection with this Contest may be used by the Roadrunners, IceArizona Holdings LLC, IceArizona Hockey Co LLC, and/or the Arizona Coyotes Foundation (together, the "**Sponsor Entities**") to contact the entrant regarding promotional updates, information, messages, and for other reasons via electronic and/or ordinary mail and will be used by the Sponsor Entities in compliance with their privacy practices. Any personal information supplied by a Contest entrant will be subject to the privacy policy posted at <https://www.nhl.com/coyotes/team/privacy-policy> ("**Privacy Policy**").

5. **WINNER SELECTION AND PRIZEWINNER NOTIFICATION:** One (1) winner will be randomly selected by Roadrunners personnel from among all eligible entries for the Prize. The drawing will be conducted on June 13, 2022. The potential winner will be notified using the contact information email provided at the time of entry. Roadrunners shall not be liable for any prizewinner notification that is lost, intercepted, or not received by a potential prizewinner for any reason. If the selected prizewinner cannot be reached or does not promptly respond to the potential prizewinner notification in the Roadrunners' discretion, a prize may be forfeited and an alternate prizewinner for a prize may be selected by Roadrunners from the remaining eligible entries. The Roadrunners will attempt to contact a potential prizewinner in accordance with the aforementioned procedure, after which the prize may go unawarded if it remains unclaimed by an alternate prizewinner. If a potential prizewinner is determined to be ineligible or declines a prize for any reason prior to award, such potential prizewinner will be disqualified, forfeit any claim to a prize, and an alternate prizewinner may be selected by Roadrunners from the remaining eligible entries.

6. **PRIZE/ODDS:** One (1) prize will be awarded to the prizewinner. The prizewinner will receive one (1) pair of Roadrunners Season Tickets for the 2022-23 American Hockey League season (the "**Prize**"). The total approximate retail value ("**ARV**") for the Prize is Eight Hundred Dollars (\$800.00). If the prizewinner is a current Roadrunners' season ticket holder, such prizewinner will receive a credit, not to exceed Eight Hundred Dollars (\$800.00), toward the purchase of such prizewinner's Roadrunners season tickets or season ticket package.

7. **GENERAL PRIZE RESTRICTIONS:** All other expenses not specified herein as part of a Prize shall be the sole responsibility of the prizewinner, including, without limitation, delivery, processing and handling, transportation, lodging, parking, food, beverage, and other purchases. No cash alternative or prize substitutions will be allowed, except that Roadrunners reserve the right to substitute a prize of comparable value if a prize listed is unavailable for any reason. A prize is non-assignable and nontransferable. If lost, the prize awarded herein will not be replaced. A prize will not be substituted, except at Roadrunners' discretion, except where prohibited by law. Prizewinner is solely responsible for the reporting and payment of any federal, state and/or local taxes on each prize received. In the event a prizewinner or such prizewinner's agent engages in behavior that (as determined by the Roadrunners in its sole discretion) is obnoxious or threatening, illegal, that is intended to annoy, abuse, or threaten any other person, or otherwise violates these Official Rules, the Roadrunners reserve the right to deem such

prizewinner ineligible and, if applicable, invalidate the prize. Delivery of the Prize will be coordinated by a Roadrunners representative and prizewinner will receive further notification with details on how to claim the Prize.

The Sponsor and its respective related entities and agents are not responsible for fraudulent communications, including without limitation phone calls or emails made by or sent to entrants. Prizewinner may be required to execute prize claim documents, including without limitation a Waiver and Release, Affidavit of Eligibility, a Liability Release and, where imposing such condition is legal, a Publicity Release (collectively, "**Prize Claim Documents**"). The Prize Claim Documents must be returned within the time frame indicated to them. If any potential prizewinner fails to return such documents within the prescribed time, if any potential prizewinner is found to be ineligible, or if they do not comply with these Official Rules, then such potential prizewinner may be disqualified and an alternate prizewinner may be selected from the remaining eligible entries. By entering the Contest, each entrant hereby: (a) agrees that the Sponsor Entities will have no liability whatsoever for, and shall be held harmless by participants against, any liability for any injuries, losses, or damages of any kind to person(s), including without limitation death, or property resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in this Contest or any Contest-related activity, or for any typographical or other error in the printing, offering or announcement of any prize; (b) releases the Sponsor Entities from all liability, claims, action, or proceedings relating to this Contest and from injuries, death, or damages arising in connection with or relating to participation in this Contest, or use or misuse of the prize; and (c) waives any right to claim ambiguity in the Contest or these Official Rules. The Roadrunners reserve the right to modify these Official Rules for clarification purposes without materially affecting the terms and conditions of the Contest, to void suspect entries and/or cancel, terminate, or suspend any portion of this Contest. This Contest may not be used for any form of gambling.

10. **IMPORTANT: PLEASE READ - GENERAL RELEASE AND LIMITATIONS ON LIABILITY.** Each entrant and prizewinner agrees that: (1) any and all disputes, claims, and causes of action arising out of or connected with the Contest, or any prizes awarded, shall be resolved individually, without resort to any form of class action; (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Contest, but in no event will attorneys' fees be awarded or recoverable; and (3) under no circumstances will any entrant be permitted to obtain any award for, and entrant hereby knowingly and expressly waives all rights to seek, punitive, incidental, or consequential damages and/or any other damages, other than actual out-of-pocket expenses, and/or any and all rights to have damages multiplied or otherwise increased. Each entrant acknowledges and agrees that the Sponsor Entities are not responsible for any costs, injuries, losses, or damages of any kind arising from or in connection with: (i) incomplete, lost, late, misdirected, or illegible entries

or for failure to receive entries due to any cause, including without limitation human, transmission, or technical problems, failures, or malfunctions of any kind, whether originating with sender, with the Coyotes, or otherwise, that may limit an entrant's ability to participate in the Contest; (ii) incorrect or inaccurate information whether caused by internet users, or by any equipment or programming associated with or utilized in connection with this Contest and assume no responsibility for any error, omission, malfunction, interruption, deletion, defect, or delay in operation or transmission, communications line failure, theft, or destruction or unauthorized access to, tampering, or hacking; (iii) any injury or damage resulting from participation in the Contest and/or the use and/or misuse of any prize (including, without limitation, claims, costs, injuries, losses and damages related to personal injuries, death, damage to, loss or destruction of property, or any claims, costs, injuries, losses, or damages related to or based on the entrant's rights of publicity or privacy); or (iv) the entrant's claim that he or she has somehow been defamed or portrayed in a false light. Sponsor Entities assume no responsibility for any errors or failures, delayed computer transmissions or network connections that are human or technical in nature, or for the incorrect or inaccurate capture of information, or the failure to capture any information. The Roadrunners reserve the right to modify, extend, suspend, or terminate the Contest if the Coyotes determine, in its sole discretion, that the Contest is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond the Roadrunners' control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Contest as contemplated herein. In the event the Roadrunners are prevented from awarding the prize or continuing with the Contest as contemplated herein by any event beyond its control, including but not limited to fire, flood, natural or man-made epidemic of health of other means, earthquake, explosion, labor dispute or strike, act of God or public enemy, satellite or equipment failure, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared) or any federal state or local government law, order, or regulation, public health crisis (e.g., SARS), order of any court or jurisdiction, or other cause not reasonably within the Roadrunners control (each a "Force Majeure" event or occurrence), then subject to any governmental approval which may be required, the Roadrunners shall have the right to modify, suspend, or terminate the Contest. If the Contest is terminated before the designated end date, the Roadrunners will (if possible) select a prizewinner in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. These Official Rules cannot be modified or amended in any way except in a written document issued by a duly authorized Roadrunners representative.

11. **GOVERNING LAW AND DISPUTE RESOLUTION:** EACH ENTRANT AND PRIZEWINNER AGREES THAT ANY AND ALL DISPUTES, CLAIMS, CONTROVERSIES, OR CAUSES OF ACTION ARISING OUT OF OR RELATING TO THE CONTEST OR ANY PRIZE AWARDED (EACH, A "CLAIM") SHALL BE (I) ARBITRATED ON AN INDIVIDUAL BASIS ONLY, AND SHALL NOT BE CONSOLIDATED OR JOINED WITH OR IN ANY ARBITRATION OR OTHER PROCEEDING INVOLVING A CLAIM OF ANY OTHER PARTY, AND (II) SETTLED BY BINDING ARBITRATION IN PIMA COUNTY, ARIZONA BEFORE A SINGLE ARBITRATOR APPOINTED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS THEN GOVERNING RULES AND PROCEDURES, AND JUDGMENT ON THE AWARD RENDERED BY THE ARBITRATOR MAY BE ENTERED BY ANY COURT HAVING JURISDICTION THEREOF.

ALL ISSUES AND QUESTIONS CONCERNING THE CONSTRUCTION, VALIDITY, INTERPRETATION AND ENFORCEABILITY OF THESE OFFICIAL RULES, OR THE RIGHTS AND OBLIGATIONS OF ENTRANTS OR THE ROADRUNNERS IN CONNECTION WITH THE CONTEST OR IN CONNECTION WITH ANY SUBMISSION OR OTHER MATERIAL SUBMITTED IN CONNECTION WITH THE CONTEST, SHALL BE GOVERNED BY AND CONSTRUED IN

THE INVALIDITY OR UNENFORCEABILITY OF ANY PROVISION OF THESE RULES SHALL NOT AFFECT THE VALIDITY OR ENFORCEABILITY OF ANY OTHER PROVISION. IN THE EVENT THAT ANY PROVISION IS DETERMINED TO BE INVALID OR OTHERWISE UNENFORCEABLE OR ILLEGAL, THESE OFFICIAL RULES SHALL OTHERWISE REMAIN IN EFFECT AND SHALL BE CONSTRUED IN ACCORDANCE WITH THEIR TERMS AS IF THE INVALID OR ILLEGAL PROVISION WERE NOT CONTAINED HEREIN.
